FIRST AMENDMENT TO DECLARATION AND MASTER DEED DEED RECORD DEL PASEO TOWN HOMES (A CONDOMINIUM)

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that the Declarant, pursuant to the rights retained by the Declarant under Section 9.1 of the Declaration, does hereby declare:

(1) that Subsection 1.1(F) of the Declaration is hereby amended to read as follows:

"(F) 'Common Elements' shall mean and refer to both the general and limited common elements described in Section 2.2 hereof. The Common Elements shall be owned by the Owners of Units in such percentages as are specified under Subsection 4.3(B) hereof."

(2) that, except as expressly modified by the terms and provisions hereof, each and every of the terms and provisions of the Declaration are in full force and effect.
